- 2) I will always promote the Tri Nature Pty Ltd Membership opportunity in an honest and truthful manner. I will not make inappropriate or exaggerated claims as to the financial rewards.
- 3) I will endeavour to maintain a high professional and ethical standard at all times in dealing with Tri Nature, my fellow Members and Consumers of Tri Nature Pty Ltd products.
- 4) I acknowledge that my acceptance as a Member makes me an Independent Contractor, not an agent or employee of Tri Nature Pty Ltd.
- 5) I agree to abide by all the Rules and Conditions, that pertain to the operation of my Tri Nature Pty Ltd Membership.
- 6) I acknowledge that the Rules and Conditions of my Membership are subject to compliance with the Provisions of the Trade Practices Act in any State and Local Laws, Rules and Regulations.

RULES AND CONDITIONS OF MEMBERSHIP

- 1) All applicants for Membership of Tri Nature Pty Ltd (known as Tri Nature) must be eighteen (18) years of age or over.
- 2) The Member shall abide by all Federal, State and Local Laws, Rules and Regulations relating to the sale and distribution of Tri Nature products and shall be solely responsible for the declaration as to income and payment of Income Tax which may accrue as a result of any Profit Sharing Bonus earned as a Member of Tri Nature. The Member shall be solely responsible for their own compensation/sick and accident insurance and superannuation.
- 3) A Member can introduce any person, including family members to Membership of Tri Nature providing that all such persons are 18 years of age or over.
- 4) At all times Tri Nature reserves the right in its sole discretion to reject any application for Membership.
- 5) A Member may not sell by retailing products purchased from Tri Nature. Tri Nature products can also be sold through Health Food Stores and/or Environmental stores, where the registered Tri Nature member is the proprietor of the store and has the express permission of Tri Nature. The sale of products through unapproved retail outlets is strictly prohibited.
- 6) The Member is responsible for all costs and expenses incurred by the Member in the conducting of their business.
- 7) A Member shall not engage in promoting any other company's product, business opportunity or name in direct competition with Tri Nature's products or business plan at any Tri Nature Members meetings.
- 8) A Member shall not engage in any other activity either directly or indirectly, by themselves or in conjunction with any other person or entity, which in the opinion of Tri Nature is in conflict with the sale of Tri Nature products.
- 9) A Member shall notify the Head Office of Tri Nature of any change of address or telephone number. If any correspondence from Tri Nature to the Member is returned unclaimed, the Member will be automatically classified as non-active and further orders will not be despatched to that Member until such time as a new postal and delivery address is given to the Company.
- 10) Members are not permitted to list their telephone numbers independently in either the White or Yellow Pages of the Telephone Directory without written authority from Tri Nature.
- 11) A Member may terminate their Membership of Tri Nature by giving seven (7) days notice, in writing, to Tri Nature. Any such notice of termination shall be without prejudice to any claim(s) by one party against the other.
- 12) Tri Nature reserves the right to terminate any Members Agreement, should there be any breach by the Member of the Agreement, by giving seven (7) days notice in writing to the Member.
- 13) A Member shall not sell, assign or transfer their Membership without approval in writing from Tri Nature. Any application to sign, sell, assign or transfer Membership shall be made in writing to Tri Nature and Tri Nature shall consider such application on its merits. Tri Nature reserves the right from time to time to issue guidelines upon which all applications to sell, assign or transfer Membership shall be considered.
- 14) Tri Nature reserves the right to amend these Rules and Conditions of Membership, Code of Ethics policies and procedures, prices and guidelines from time to time in the best interests of Tri Nature and its Members. All Members will be notified in writing of any amendments to these Conditions of Membership and all amendments are automatically incorporated as part of the Membership agreement.
- 15) Tri Nature guarantees that only the highest quality raw components are used in the manufacturing of their products. If for any reason a Tri Nature product is found to be unsatisfactory, on return to Tri Nature through a Member within 60 days, the full purchase price will be refunded to the Consumer.
- 16) The Member shall investigate fully, any consumer complaint. Should the consumer be unable to achieve a satisfactory outcome then the matter must be reported to Tri Nature.
- 17) Tri Nature Members will not at any time use a Tri Nature Members list to procure Members or Distributors for any other direct selling company, network marketing company or multi level marketing company, nor are they to pass a Tri Nature list onto any other persons or company to use as an addition to a database mailing list or use in recruiting members or distributors for a direct selling company, network marketing company or multi level marketing company. Tri Nature Members lists always remain the property of Tri Nature. Members dishonouring this agreement will have their Tri Nature Membership agreement terminated immediately, forfeiting any outstanding monies owed to them at the time of termination.
- 18) If on receipt of delivery product is found to be damaged, the Member is to complete a Returned Goods claim form. On receipt of this form, the Member will receive replacement stock or the Members account will be credited with the cost of the product to the Member.
- 19) Products which are not required by the Member must be returned within fourteen (14) days. If a Member requests replacement products these will be despatched at the Members expense. No goods will be despatched for return after a period of fourteen (14) days from the date on which such goods will have been received in the normal course of delivery (see Rules and Conditions for customer guarantee details).
- 20) The Tri Nature month ends at 5pm (EST) on the last business day of each calendar month. All orders received after 5pm (EST) on the last business day of the month will automatically be processed in the following month.
- 21) All telephone and faxed orders are to be received before 11.00am (EST) for despatch the following day. Tri Nature has Bankcard, Mastercard and Visa Card facilities available for Members convenience. When an order is paid for by credit card and the credit card is declined by the Bank for any reason, then the order will be held until the authorisation is received. Please note that when payment is made on the credit card, a time lapse of seventy two (72) hours may occur before authorisation to proceed with purchase is given. Tri Nature Administration Staff will make every endeavour to contact the Member should a credit card be declined, however the payment always remains the responsibility of the Member.
- 22) No Member may represent Tri Nature or speak for Tri Nature or its products to the Media. Should a Member be approached for this purpose all enquiries should be directed to Tri Nature. A Member may advertise for potential Members using the Tri Nature logo only after receiving written permission from Tri Nature.
- 23) A Tri Nature Member may only use advertising material that has written approval from Tri Nature. Members using non-approved advertising material will have their membership agreement terminated.
- 24) Tri Nature calculates all Profit Sharing bonus payments and will despatch payments earned by Members on a monthly basis (see Rules and Conditions for terms of bonus qualification).
- 25) All products are packaged under strict quality control in specifically designed and approved containers. Re-packaging/refilling of any product for the purpose of reselling that product is strictly prohibited. Labelling and Health Department Laws expressly forbid such repackaging as the product guarantee and Product Liability Protection may be void if products are repacked.
- 26) Business and Training Meetings are held for the benefit of all Members. Though there is no obligation to attend, Tri Nature encourages attendance as the content of these meetings is beneficial to all Members in assisting in their understanding of Tri Nature products and the Company.
- 27) Ask your Sponsor for your copy of the Rules and Conditions of Agreement and familiarise yourself with the conditions applicable to bonus payments (pts 3 & 3a) and freight free qualification status (pt 13f).
- 28) It is expressly agreed that any arbitration entered into, in relation to any part of this Agreement, is to be dealt with under the laws of New South Wales in the State of New South Wales.

RULES AND CONDITIONS OF AGREEMENT

Policies and Procedures

Effective 1st November 2007

The following are guidelines under which the Members of Tri Nature operate, in conjunction with the Rules and Conditions of Agreement on the Full Membership Application Form.

Members Code of Ethics

1. I agree to conduct my Tri Nature business according to the Code of Ethics.
2. I intend to be a 100% personal user of Tri Nature and retail the products to others.
3. I will actively seek product sales and endeavour to establish a reasonable retail clientele, servicing my customers to their satisfaction and delivering their orders in a timely manner.
4. I will never say or do anything to any Member that will make that Member dissatisfied with the Company, his/her Sponsor, or Upline Leader.
5. I will always place great value on my own good name and that of Tri Nature's. I will endeavour to maintain a high professional and ethical standard at all times when dealing with my Company, my fellow Members and my Customers. I will teach my Downline Members to do likewise.

As an Independent Distributor of Tri Nature Products, the Member is solely responsible for the declaration of income and payment of income tax or GST which may accrue as a result of the commission earned by the Member, who accepts sole responsibility for their own workers compensation/sick/accident insurance and superannuation. Husband and wives cannot have different sponsors. Couples can only hold three accounts, Self, Spouse, Family Company or Family Trust.

Recruiting Procedures

1. Members can solicit orders or recruit Members in any area, accepting the responsibility to train and support new Members in their Tri Nature business. Failure to do this could see a Member lose their Sponsored Member to their Upline.
 - 1.a. Members making contact with a new prospective Member should conduct a follow-up within four days. Other Tri Nature Members must respect the first Members right to recruit the new prospect, allowing them preference for a period of up to thirty (30) days, from the first contact.
 - 1.b. Each Member is responsible, before joining up a new Member, to ascertain where they heard about Tri Nature and from whom. If applicable, the approaching Member should pass this person on to the initial contact. However, it is ultimately the right of each individual to choose the person they wish to have as their sponsor, before signing the Agreement form.

Representation

2. Members shall not promote any other Company's product, business opportunity, or name within a Tri Nature meeting, trade show stand, or demonstration. Failure to comply could lead to termination of the Membership Agreement.
 - 2a. Members shall not produce and sell to other Member's business information, promotional resources without prior approval from their Upline Manager or the General Manager of Tri Nature.

Commissions

3. Tri Nature agrees to pay the commissions and bonuses due on bona fide sales at the rates stipulated in Tri Nature's Business Compensation Plan but reserves the right to deduct from any bonuses due to the Member any outstanding monies due to Tri Nature by the Member.
 - 3.a. Extra Bonuses will only be paid on sales of \$141.00* or more per month and Personal Sales Bonuses and Link Profit Sharing Bonuses will only apply to orders over \$200.00* or more per month. Tri Nature reserves the right to change these volumes in the interest of Tri Nature and Tri Nature's Members (see the Tri Nature Business Plan for details).

* Ex GST, freight & non-commissionable items

Change of Address

4. Members must notify Head Office of change of address or telephone number. This will ensure all Members' details are kept up to date.

If any returned mail is received, that Member will automatically be considered non-active. Until the details are corrected, the Member will not receive Company mail-outs.

Telephone Listings

5. Tri Nature is listed in the white pages in each capital city. Managers and above can have their names included. A request in writing must be submitted and the inclusion will be at the Member's expense. Free call numbers are not permitted.

Transferring Sponsors

6. Transferring / changing of Sponsors is not endorsed nor encouraged by Tri Nature as it creates fragmentation within the organisation. Members wishing to change need a written letter of agreement from their original Sponsor
 - 6.a. To change Sponsors, a Member must first resign from their Membership. Termination of the agreement must be received in writing. Upon resignation, any Downline group Members will be assigned up to their own original sponsor, remaining in their original group.
 - 6.b. After a period of 6 months, the resigned Member may apply to rejoin Tri Nature under a new sponsor. If accepted they must purchase a new Members joining pack and will then be rejoined under their new sponsoring Member. Tri Nature reserves the right in its sole discretion to reject any Membership application.

Agreement Termination

7. If a Membership Agreement is terminated, the Downline of the terminated Member will move to the next Upline Member.
 - 7.a. Members are not to say or do anything to any Member that will make that Member dissatisfied with the Company, his/her Sponsor or Upline Manager. Failure to comply may lead to termination of their Membership Agreement.

Annual Renewal

8. Membership must be renewed annually. On the anniversary of joining, an invoice will be sent from Tri Nature. Payment is required within 4 weeks from the date of invoice. If payment is not received within the specified time, it will be assumed that the Member does not wish to remain a Member of Tri Nature and their Agreement will be cancelled. Downline of the cancelled Member will move to the next Upline Member. Should the cancelled Member wish to rejoin at some future date they will have forfeited the right to their original Downline.
 - 8.a. The annual renewal fee of \$27.50 covers the cost of the Company newsletter, bookkeeping and Downline Maintenance fee, and any additional correspondence despatched by the Company during the year.

Companies / Partnerships / Family Trusts.

9. Applicants wishing to trade as a sole proprietor or partnership using a business name or as a Company, the Business

Registration Number or ACN Number must be included on the Agreement Form, with the name of a contact person included. All communication will be directed to that person. For Family Trusts, the Trustees name will be required for contact. All business names must be a legally registered business name.

Sales and Wiling of Memberships

10. A Member shall not sell, sign or transfer their Membership without the Company's approval. Memberships may be sold (provided that no Upline or Downline is disadvantaged) and can only be offered for sale to the Upline Sponsor or a Member who was personally sponsored by the Member wishing to sell, or to the Company. People outside the Company cannot purchase a Membership.
- 10.a. In the event of a death, a Membership may be willed, providing a copy of the Death Certificate and formal proof of the inheritor are provided to the Company. Tri Nature will not enter into any dispute and will only recognise one inheritor, whether it is an individual, a business or married couple.

Retailing

11. Stands and exhibits at Trade and Environmental Shows are acceptable, providing they portray a professional image. Flea markets and street stalls are **NOT** suitable. Queries can be addressed to our Head Office.

Complaints, Guarantees and Refunds

12. The limit of the Tri Nature "Money Back" satisfaction guarantee is 60 days.
- 12.a. If a customer is unhappy with a product, ensure they are using the product correctly and are expecting the correct results. Your instruction and guidance in this area can help you to retain your original sale and future sales with this customer.
- 12.b. Members shall investigate fully any customer complaint and notify their Upline Manager, should difficulties arise. The Manager will assist until customer satisfaction is achieved. Should a satisfactory outcome not be achieved, the matter must be reported to Tri Nature. Members shall honour the Tri Nature guarantee whenever this is warranted.
- 12.c. On receipt of a completed "Returned Goods Form", the Members account will be credited by the cost of the product to the Member. Goods credited may impact on the commissionable sales total of the Member and it is up to the Member to ensure bonus qualification requirements are met.

Ordering and Shipping

13. Orders are processed in the month received, unless accompanied by a written request to do otherwise. Tri Nature endeavours to process and despatch within 48 hours (except in back order situations.) Deliveries generally arrive within 5 working days of despatch. Should this not occur, please notify Tri Nature immediately.
- 13.a. Orders must be paid for before despatch. *Please note: when a payment is made on a credit card it can take up to 72 hours before the authorisation to proceed with purchase is given.*
- 13.b. In back order situations, a back order notice will be attached to the invoice. A credit is not issued against the payment made for these products, as they will be sent out as soon as they come into the warehouse. These products are still calculated in the total sales volume to ensure qualification for commission and bonuses in the month the order was placed.
- 13.c. **Standard Order Form** - Members can place a standard monthly order to ensure payment of Commission and Bonuses. Standard orders must be of a minimum value of \$200.00* or more of commissionable product items plus \$15.00 delivery (Inc GST). Standard orders can only be placed with the use of a Credit Card and forms must be completed with Credit Card Authorisation and Number.
- 13.d. **Backup Order Form** - Should a Member fail to place their minimum \$200.00* order in the month, (e.g. go on holidays, take ill etc) a pre-placed order can be sent out on the last day of the month. An \$15.00 Delivery Charge will be added. Backup orders can only be placed with the use of a Credit

Card and forms must be completed with Credit Card Authorisation and Number.

- 13.e. **Support Order Form** - Protects those Members who place orders during the month believing them to be over the \$200.00* qualifying amount and in the calculation of the invoice are found to be below \$200.00*. On the last day of the calendar month, Members with a Support Order in place whose calculations have not reached the minimum of \$200.00* for commissionable product items, will be sent a Support Order (of their own choosing) to the minimum order value of \$75.00*. Support Orders can only be placed with the use of a Credit Card and forms must be completed with Credit Card Authorisation and Number. *NB: When calculating orders, please consider any credit adjustments that may have been given, as these will affect the balance of your order.*
- 13.f. **Freight Free Qualification** – You must place a minimum of 1 single order with a minimum net value of \$300 each month for 3 consecutive months to qualify for freight free status in the 4th month. You will be entitled to receive 1 freight free order per month provided you continue to place a minimum of one order with a minimum net value of \$300 each month. Failure to place a qualifying order in any single month voids your status and you must recommence the qualification process.
- 13.g. Tri Nature may, in addition to any amounts payable by the Member/Customer under these terms, require payment of any amount of goods and services tax which is payable or may be payable in respect of the provision of goods/services to the Member/Customer or anything else under these terms.

Media and Advertising

14. No Member may represent or speak for the Company or its products to the media without prior permission. This includes interviews on radio, television or through the press, including periodicals. Please refer all enquiries to the Company.
- 14.a. Members may only use advertising material that has prior written approval by the Company. Use of non-approved advertising material is cause for termination of a Membership Agreement. Use of the logo also requires written approval.

Internet Web Site

15. Members may advertise for potential Members/Customers on the Internet, with prior written permission from the Company. This is also necessary for any amendments to the site. Persons contacting Tri Nature through the Company website will be directed to the nearest Active Member.

Maintenance Fees and Link Reports

16. Members at the level of Manager (Gold), upon the Company receiving a signed confidential Affidavit, will receive a complimentary printed Link Report on their total Downline. It will thereafter be available upon request at 50 cents per page (a cost incurred in the operation of your business and deemed as a tax deduction). If a signed Affidavit is not received from a Manager, that person will not be eligible to receive Link Reports. Link Reports remain the property of Tri Nature and are not to be passed on to any other person for use as an addition to a data base mailing list or in the recruitment of Members for other Direct Selling Companies, Network Marketing Companies or Multi Level Companies. To disregard this directive will attract instant termination of the Membership Agreement and any outstanding Commissions or Bonuses will be forfeit.

Meetings

17. Appropriate dress regulations are required at all business meetings. Please ensure that your guests are also appropriately dressed - jeans, shorts, singlets and thongs are definitely not acceptable.

By signing the Tri Nature Independent Members Agreement Form, the Member agrees to be bound by the Tri Nature Conditions of Agreement, which includes the Code of Ethics and Policy and Procedures. The violation of these Conditions could provoke the termination of the Membership Agreement

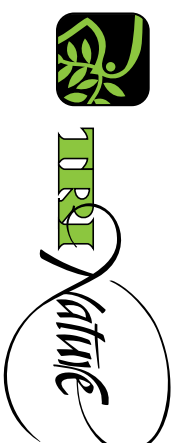

We have prepared this pro-forma Statement for distributors who DO NOT QUOTE AN ABN. This Statement is most important if you expect to receive total monthly GROUP SALES bonuses (i.e. LINK or BREAK AWAY) of \$50,00 or more.

Upon receipt of a signed 'Statement by a Supplier', Tri Nature Pty Ltd **WILL NOT BE REQUIRED**, under the Pay As You Go (PAYG) system to withhold 48.5% of your monthly group sales bonus.

The statement relates to the supply by you of your services under your Membership Agreement with Tri Nature and should be submitted to Tri Nature Pty Ltd to comply with ATO guidelines if:

- you are an individual and the supply is wholly of a private or domestic nature
- OR**
- the supply relates to a private recreational pursuit or hobby (and does not have the characteristics of a business)

The Statement need only be provided to Tri Nature ONCE. If your circumstances change, however, the ATO requires that you revoke the Statement in writing as soon as practicable.
